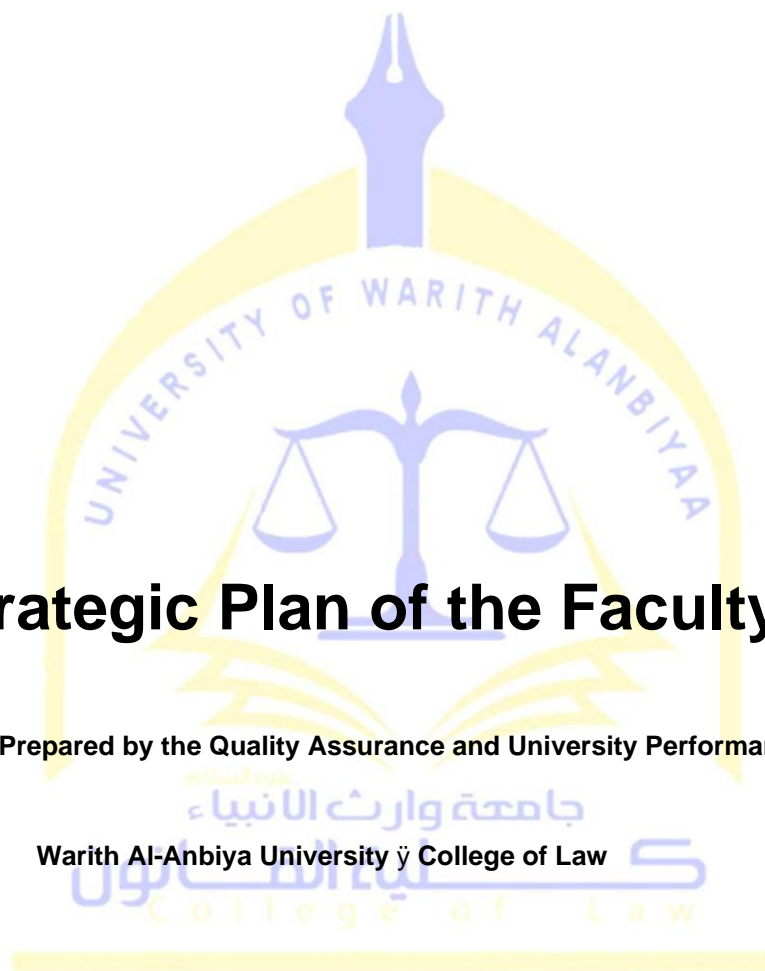

Time period: 2024-2029:

Vision:

To be a pioneer in legal education, distinguished in preparing lawyers, judges and professional legal professionals capable of promoting justice and protecting rights, while adhering to high academic standards and sustainable legal practices.

The College of Law seeks to provide high-quality legal education based on scientific research, practical practice, and innovation, through developing curricula, enhancing communication with legal institutions, and developing students' skills to become leaders in the legal field capable of facing contemporary legal challenges.

Strategic objectives:

Improving the quality of academic education¹.

• **Curriculum development:**

- o Update curricula periodically to keep pace with changes in the local and international legal system.
- o Adding new courses that reflect modern trends in law such as **international law, environmental law, human rights, artificial intelligence and law.**

• **Interaction with the international academic community:**

- o Enhancing cooperation with international universities and research centers through academic exchange and developing joint programs.

- **Enhancing teaching skills:**

- o Organizing workshops and training programs for faculty members to improve Modern teaching methods and educational techniques.

2. Promoting scientific research and innovation.

- **Encouraging scientific research:**

- o Providing research grants for faculty members and students to enhance scientific research in legal fields.
- o Establishing specialized research centers in branches such as **criminal law, commercial law, and human rights**, to ensure the development of legal knowledge.

- **Publishing research and participating in international conferences:**

- o Supporting the participation of professors and students in international conferences to publish legal research and exchange experiences.

- **Development of legal databases:**

- o Establishing an integrated digital legal library containing global and local legal databases.

3. Achieving excellence in community service and partnerships with legal institutions.

- **Interaction with the legal community:**

- **Community service initiatives:**

- o Establishing free legal clinics to provide legal advice to citizens in simple cases, in cooperation with college students under academic supervision.

- **Legal Consulting Program:**

- o Providing specialized legal advisory services to government institutions and private companies to enhance the college's societal role.

• Training and practical programs:

o Providing specialized training programs and workshops in professional skills such as:

Litigation, legal writing, negotiation, and arbitration.

o Providing practical training opportunities in legal institutions and major companies.

• Career guidance:

o Establishing a career guidance center that provides career advice to students and graduates, and directs them towards appropriate legal work fields.

• Supporting legal innovation:

o Encouraging students to innovate legal solutions to contemporary problems by organizing legal competitions and incentives for creative ideas.

• Expanding the alumni network:

o Establishing a network for college graduates with the aim of enhancing professional communication and providing professional support to graduates.

5. Achieving administrative excellence and developing resources.

• Improving administrative processes:

o Developing the college's administrative and digital systems to ensure that services are provided more effectively and quickly.

o Create an electronic platform for college students to advertise training courses, lectures, legal activities, and employment opportunities.

• Sustainable development of financial resources:

Explore additional funding sources through partnerships with legal institutions, donations, and o research grants.

o Organizing fundraising events to support academic and research activities.

• Modern educational facilities:

o Upgrading educational facilities, such as classrooms and libraries, to provide a modern and advanced learning environment.



Main activities for implementing the strategic plan:

1. Updating academic curricula:

2. Launching specialized training programs:

- o Organizing annual legal scientific conferences in cooperation with international institutions to exchange research and discuss global legal issues.

- o Signing agreements with law firms and judiciary and joint training programs with legal institutions abroad.

.5 Development of digital platforms:

- o Developing electronic applications and platforms that facilitate the communication process between Students, professors, and academic administrations
