### 1. College Establishment

The establishment of the College of Islamic Sciences, with its three departments (Quranic Sciences, Jurisprudence and its Principles, Islamic Financial and Banking Sciences), has undergone multiple stages:

#### **First Stage: Committee Formation for Establishment**

Following the university decree numbered (ب.ق.م.ب/123 on 14/2/2018), a specialized committee was formed for the establishment of the College of Islamic Sciences. Additionally, the committee for the establishment of the Department of Islamic Financial and Banking Sciences was formed according to the administrative decree numbered (س.ك.ع.س/222 on 10/11/2020), as outlined in the attachments below.

#### **Second Stage: Ministry Approval for the Founding Faculty of Islamic Sciences in Light of the University of Warith AlAnbiyaa Letter**

In accordance with the University of Warith AlAnbiyaa letter that indicated the establishment of the College of Islamic Sciences, the Ministry of Higher Education and Scientific Research, in its letters (ت.ه.أ.ق/ 10589 on 27/6/2018), (ت.ه.أ.ق/ 10590 on 27/6/2018), and (ت.ه.أ.ق/ 8833 on 15/7/2021), approved the faculty members for the departments of (Jurisprudence and its Principles, Quranic Sciences, Islamic Financial and Banking Sciences). as outlined in the attached document are as follows:

#### **Third Stage: Approval of Establishing the College with its Departments:**

Following the proposal from specialized committee for the establishment of the College of Islamic Sciences and the approval of the Ministry of Higher Education and Scientific Research for the faculty members of the departments (Quranic Sciences, Jurisprudence and its Principles, Islamic Financial and Banking Sciences), the Ministry approved the establishment of two departments (Jurisprudence and its Principles, Quranic Sciences) as per its letters (ت.ه.أ.ق/ 15552 on 23/9/2018) and (ت.ه.أ.ق/ 15553 on 23/9/2018). Additionally, the establishment of the department (Islamic Financial and Banking

Sciences) was approved according to the letter numbered (13852 ت.هـ.أ/ق) on 24/11/2021), as detailed in the attached document below.

## 2. Vision, Mission, and Objectives of the College of Islamic Sciences

The College of Islamic Sciences, guided by the vision of the University of Warith AlAnbiyaa (peace be upon him), aspires to be a leading and distinguished institution in the field of Islamic sciences. It aims to achieve quality standards in the areas of Islamic thought and teachings, making it an academically and research-wise outstanding institution at the local, regional, and global levels

5. Provide the Arab and Islamic worlds with specialists capable of presenting a positive image of Islam and Muslims in all aspects



related to Islamic beliefs, Sharia, sciences, ideas, and civilization, contributing to the global civilization project.

6. Contribute to imparting a comprehensive set of Islamic knowledge and specialized sciences to students throughout the entire study program, enabling graduates to practice the teaching profession in secondary schools in the religious fields and to be legal experts.

The college's deanship aspires to open new departments in addition to the existing ones, focusing initially on establishing the departments of Jurisprudence and its Principles and Quranic Sciences in its first year. In 2022, the Department of Islamic Financial and Banking Sciences was established at the undergraduate level. However, in the coming years, the college aims to open admission for other departments at higher levels, such as master's and doctoral programs. This is in its pursuit of reviving the sciences of Sharia in intellectual and doctrinal fields while balancing between religions, sects, Arabic language, and the noble Hadith.

#### **4. Admission Requirements**

A student holding a secondary school certificate is accepted based on the conditions and regulations issued by the Ministry of Higher Education and Scientific Research. The secondary school certificate should be from the following branches:

- A. Scientific Branches: Biology and Applied Sciences.
- B. Commercial Branch.
- C. Literary Branch.
- D. Secondary schools of both Shiite and Sunni Waqfs whose students have taken the evaluative exam for both morning and evening studies.
- E. Islamic secondary schools affiliated with the Ministry of Education, for both morning and evening studies.
- F. Institute for Teacher Preparation in the specializations of Islamic Education and Arabic Language.

## **Secondly: Administrative Structure of the College of Islamic Sciences**

#### **G: Media and Documentation Committee**

- Introduction of the college's significance and mission, working towards building a positive image internally and externally.

- Preparation and issuance of newsletters, especially those related to the college's achievements and events, distributed within and outside the college.

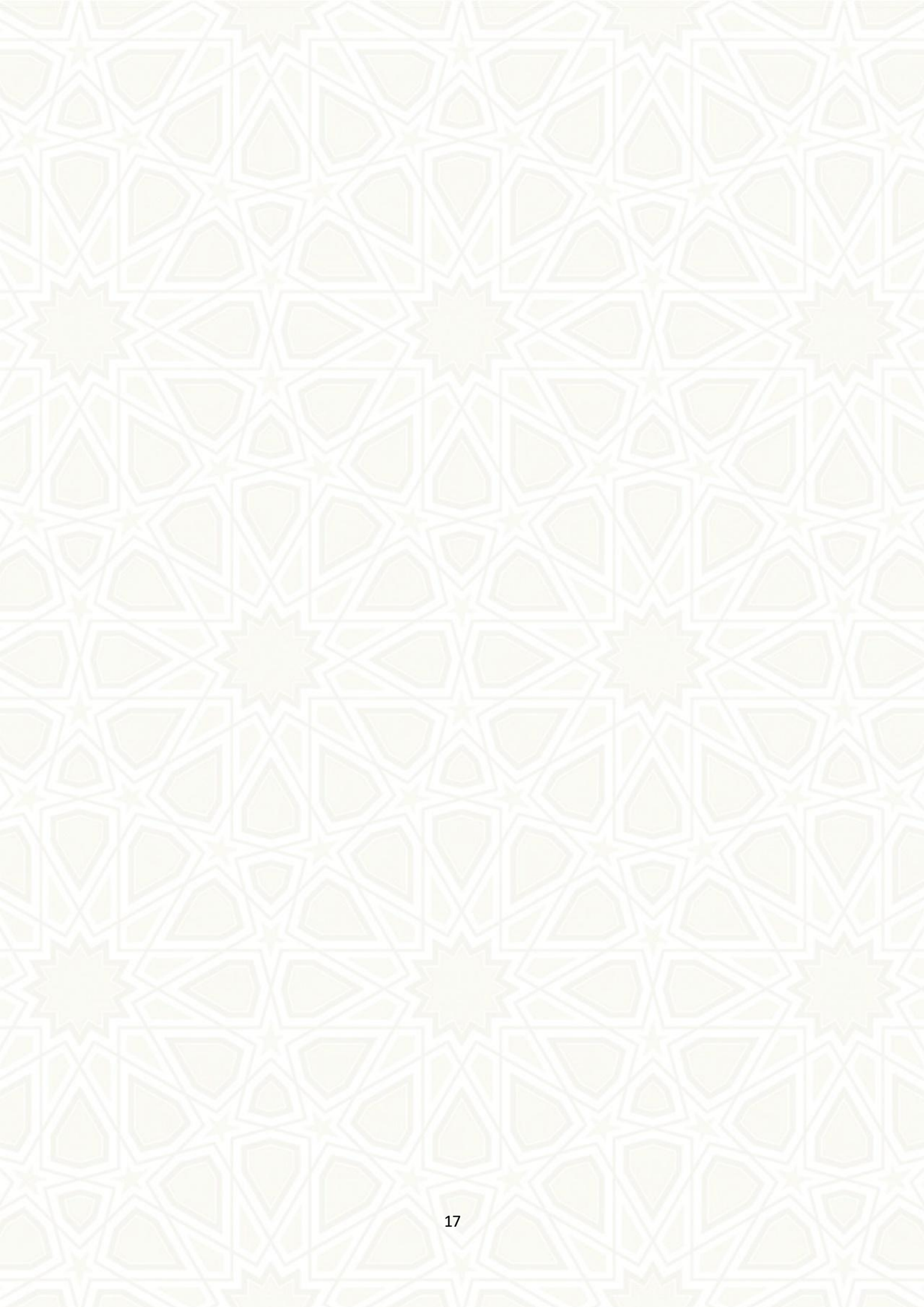
